

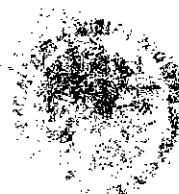
En la Ciudad de Tlaxcala, en ocho de mayo de dos mil veintitrés-----
